Ruby R. Vale

Ruby R. Vale (1874 – 1961), born in Carlisle, Pennsylvania, was the son of Joseph Griffith and Sarah Ruby (Eyster) Vale. He was named after his maternal grandmother's family. He received his secondary education at the Dickinson Preparatory School, and he later graduated from Dickinson College in 1896 with bachelor of Philosophy degree. In 1896 he came to Milford, Delaware, to teach and serve as principal of the Milford Classical Academy.

In 1898, Vale left the Academy and returned to Dickinson College to study law. In 1899, he received his Bachelor of Laws and Master of Arts degrees. He was admitted to practice in Pennsylvania in 1899, and became associated with the Philadelphia law firm of Alexander and Magill. After Alexander's death, he continued as a partner of Magill. Thereafter, Vale practiced independently for many years in Pennsylvania, specializing in corporation, banking, and insurance law. He was highly regarded by judges and members of the Pennsylvania Bar. Vale was also a prolific writer of scholarly articles and treatises on negotiable instruments, mechanics' liens, and



rules of the Superior Court of Pennsylvania. He is perhaps best remembered for his multivolume work titled, *Vale's Pennsylvania Digest*, which for many years was the authoritative source of Pennsylvania law.

Ruby R. Vale married Maria
Elizabeth Williams on January 21,
1901, in Milford, Delaware. The
couple made their residence in
Milford in the Williams family
home. After it was destroyed by fire,
the Vales paid for construction of a
new city hall on the site and donated
it to the city of Milford.

The Ruby R. Vale Foundation was formed upon his death. It provides financial support for the Ruby R. Vale Distinguished Scholar Program.

For the past 27 years, competitors from prestigious law schools throughout the country have participated in Vale. In March 2016, 18 teams from 17 law schools participated in our competition. The competition gives law students the opportunity to address current corporate legal issues with members of the Delaware judiciary and Delaware corporate legal community.

Description of the Competition

The Corporate Competition is an interscholastic appellate moot court competition sponsored by the Moot Court Honor Society of Delaware Law School. Attorneys and judges from the bench and bar of Delaware, Pennsylvania, and New Jersey judge each round of the competition. The problem will contain at least two corporate issues of current legal relevance. The competition is open to the first 24 teams to register. Each school may enter one team and also place a second team on the wait list. The second team will remain on the wait list until October 28, 2016. At that time, if space is available, the second team will be admitted. A team may consist of two or three members.
