Jar( aW Lawrence A. Cunningham is Managing Partner for the Quality Shareholders Group, Special Counsel with Mayer Brown LLP, and Tucker Professor Emeritus of George Washington University. He has written 20 books, 50 research articles, and 100s of columns, including his self-published international best seller *The Essays of Warren Buffett: Lessons for Corporate America*. Cunningham has served on several public company boards, including currently Constellation Software Inc. (TSX:CSU), where he is board vice chairman, and Kelly Partners Group (ASX:KPGH).

A Delaware native, Cunningham worked for Skadden's Wilmington and New York offices throughout college and law school (1981–1987) before practicing corporate law for six years with Cravath, Swaine & Moore in New York (1988–1994). During his distinguished academic career, Cunningham delivered lectures at 40 different universities around the world. In 2018, he received the B. Kenneth West Lifetime Achievement Award from the National Association of Corporate Directors.

### **History of Pileggi Lecture**

In 1985, Francis G.X. Pileggi, who was then the Internal Managing Editor for the *Delaware Journal of Corporate Law*, envisioned creating a forum where practitioners, judges, and academics, distinguished in the area of corporate law, could speak directly to those most responsible for setting policy on corporate law in the United States—the Delaware bench and bar. Through his efforts and the generosity of his father, Francis G. Pileggi, the idea turned into reality.
