### **Diversity Scholarship**

The Heckler & Frabizzio Diversity Scholarship's mission is to assist minorities to pursue a career in the legal profession in Delaware. The scholarship will award a one-time \$5,000 financial scholarship towards legal courses of the winner's choice.

#### **Eligibility:**

- Open to all high school seniors, college students, or graduate students residing in the state of Delaware attending a Delaware College, University, or accredited program. Individuals who do not meet the stated eligibility but have strong connections to Delaware with intentions to work in the legal field in Delaware after graduation are also welcome to apply.
- Applicant's must be from an underrepresented population
- All applicants must pursue their passion in legal-related fields. (Examples: Criminal Justice Major, Legal Studies, Paralegal Certificate, Political Science, etc.)

#### **Application Requirements:**

- The candidate must complete the application.
- The candidate must submit an essay responding to selected prompts.
- The candidate must attach a class schedule or transcript for proof of enrollment.
- Candidates may include their resumes, recommendations, or other relevant documentation. (Optional)
- The candidate must be willing to participate in a personal interview if requested.

#### **Application Deadline & Instructions:**

To be eligible for the Diversity Scholarship, candidates must email their complete application and supporting documents to <a href="mailto:nbogia@hfddel.com">nbogia@hfddel.com</a> by July 15th, 2025 . Any applications sent after this date will not be considered.

Diversity Scholarship applications should be sent with the subject line "[Applicant's First & Last Name] – 2025 H&F Diversity Scholarship".

Once your application has been reviewed by Heckler & Frabizzio, you may be selected to participate in a 30minute personal interview with the Diversity Committee at Heckler & Frabizzio.

The recipient of the H&F Diversity Scholarship will be chosen and notified by August 15th, 2025.
